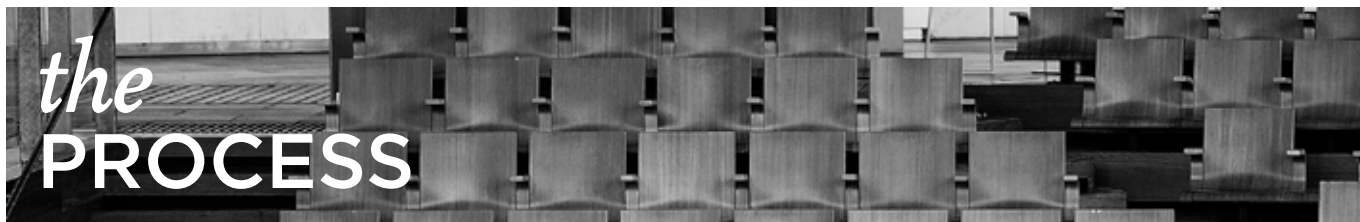
SOLUTION

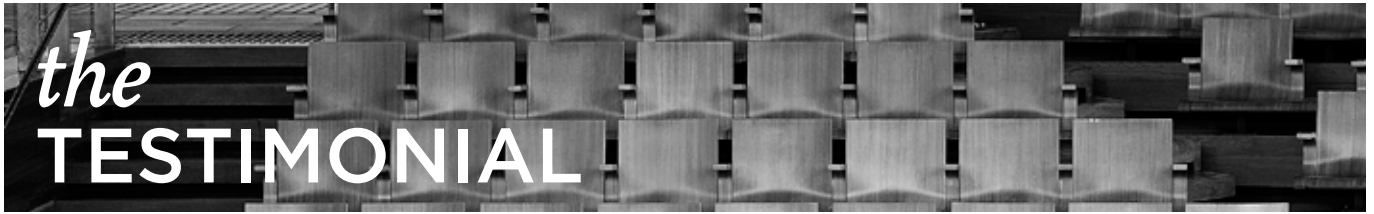
